DISADVANTAGED BUSINESS ENTERPRISES (DBE): A minimum goal of 3.5% has been established to be subcontracted to Disadvantaged Business Enterprises.

- 3) The dollar value of each proposed DBE subcontract.
- 4) DBE subcontractors not listed in the MnDOT Directory of Disadvantaged Business Enterprises will be required to apply for certification through Minnesota Unified Certification Program (UCP).

Bidders/proposers will be prohibited from entering into agreements with a DBE in which the DBE promises not to provide subcontracting quotations to other bidders/proposers.

A bidder's or proposer's failure to show good faith effort to achieve specified contract goals for the participation of Disadvantaged Business Enterprise in the completion of this project will be grounds for finding the bid or proposal non-responsive.

RESPONSIBLE CONTRACTOR VERIFICATION: A contractor responding to this solicitation document shall submit to the County a signed statement under oath by an owner or officer verifying compliance with each of the minimum criteria in Minnesota Statues, section 16C.285, subdivision 3.
