## **Instructions for filling out the Address Application**

Fill in the required blanks (noted by the asterisk) and all other blanks that are applicable and return the application along with the \$100 fee to the Fillmore County Zoning department. A new address will not be assigned for the property until the following requirements have been met:

- The zoning permit has been issued
- The driveway is constructed or staked
- The driveway has been marked on a 2008 Aerial Imagery Map provided by Fillmore County
- If driveway has not been marked, an additional fee of \$50.00 will be assessed to do a site check on the driveway status
- The application fee has been paid in full

***If you have noted on your application that the driveway is not constructed, it is your responsibility to notify the county (by phone, fax, or email) when the driveway has been staked or constructed.*** County staff will then visit the site and assign an address to the location. You will be notified by mail within 1 week of the site visit of the new address.

The **County** for which the new address has been assigned to is responsible for the installation of signage indication the new rural address number. Please read the attached document on how to properly display the new address numbers.
